**Waiver and Release of Liability**

For consideration of \$1, or the cost included in the Field Fee, or for consideration of furnishing services, equipment or a combination thereof to enable me to participate in the paintball games, I agree as follows:

I, the undersigned, fully understand and acknowledge that:

- (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities;
- (b) my participation in paintball activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, strains, bruises, fractures, disease, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability;
- (c) these risk and dangers may be caused by the negligence of the owners, employees, officers, or agents of Mad Ivan's Paintball; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and
- (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or part by the negligence or other conduct of the owners, agents, officers, employees of Mad Ivan's Paintball, or any other person.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Mad Ivan's Inc. and it's owners, agents, officers, and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise, which may arise out of my use of paintball equipment or my participation in paintball activities, I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, agents, officers or employees of Mad Ivan's Paintball.
